A. Competition: official application, a CD and other information. at WSMA Competition Site

1. Send you're **official application, a performance CD and other required information to WSMA.**
 - 1) A. every month, B. every quarter (three month), C. every 6 month, D. every year:
all the entries must be received correct date. Monthly: the 1st of the month to the end of month.
 - 2) Format: 1. Martial arts presentation, 2. Introduction of contestant
(Optional: 1. Formal dress presentation 2. Personal presentation: include speech)
 - 3) WSMA has the right to choose all the judges for Local, Regional, State, National, USA, International and World Competition.
 - 4) WSMA may publish the result of the competition on the www.worldSMX.com, www.missMartialArts.com, www.mrMartialArts.com and/or other magazines including contestants of their competition results. The results may be notified individually by e-mail, website and /or other sources.

2. This event does not require **USA Residency or Black Belt rank**.
3. **All are Welcome:** Any Ranks, Ages, and Styles.
4. Mail your Application, required papers, introduction of contestant and a Performance CD to WSMA.
5. You do not need to travel to the competition site. If it is necessary WSMA will announce the changes,

7. WSMA reserves the sole right of decision for all event locations, venues and dates. WSMA reserves the right to change or cancel all and any events or programs.

- ❖ **Performance of martial arts:** Showcase of displaying martial arts performance as well as high standard of life, health and education.
 1. Discipline, respect, and devotion.
 2. Balance, power, timing, breathing, and determination.
 3. Overall presentation.

■ **Contestants must follow the rules:**

1. Must register WSMA official competition application,
2. Fee payment:
 - a. Must be paid with a WSMA official application before due date. Received at WSMA HQ not by postmark.
 - b. Bank certified check, money order by mail. No personal checks or company checks.
 - c. No refund any and all the information received from any applicants advertiser and/or any sources whatsoever whether attended the event or not and/or events were held or not, WSMA is not responsible returning any of the information. WSMA has the right to change the event venues, dates, rules and regulations.

Option: Following information is optional and WSMA will decide for this option for the level of the competition of State, National and International Event.

3. **An essay:** on the impact martial arts has had on your life. Must be typed or printed not handwritten.
4. Total of 4 recommendations:
 - a. School teacher, school students.
 - b. Martial arts instructor from established martial arts school or studio.
 - c. Parent/guardian (if not, relatives or close person)
 - d. One from non-family member:
5. for School students: include school record; recommend an average of "B" or higher

■ **Notification of acceptance:**

1. Qualified contestants may be notified individually from WSMA by e-mail or phone.
2. All qualified contestants may receive a certificate of qualification.

■ **Rules and regulations:** Some of Following information is optional and WSMA will decide for this option for the level of the competition of State, National and International Event.

Contestants are **NOT** required to have a black belt rank. Any level of martial artists can compete in the events in their division.

1. All contestants must be students of an established legal martial arts school (following information is an option: and must be sponsored by the martial arts school which is instructed by a black belt and must provide all information with the application). Rules will be fair and strictly enforced. All competitors, officials, and volunteers must obey them if it is necessary.
2. Any divisions with less than Ten competitors may be combined with the next closest division only by WSMA.
3. WSMA has the right to stop, cancel, refuse, revoke or reject contestants' performances before, during and/or after the presentation as well as the event venues for safety, quality, or decency to protect contestants' and/or others.
4. **Uniforms:**
 - a. All contestants must wear a regular formal traditional clean martial art uniform. NO Shorts, t-shirts, short sleeved tops, warm-up styled garments or uniforms are allowed.
 - b. Only WSMA has the right to decision of the rules. Any special uniforms and garments must be approved by WSMA prior to the competition.
 - c. WSMA recommends a one colored uniform. More than two colors of material of mixed uniforms are not allowed.
 - d. Must wear a traditional belt.
5. **Dress Code:** Officials, masters and guests must wear a formal suit, tie and dress shoes. No sneakers or sports shoes are allowed.

6. Contestant **must remove all jewelry for safety** and are responsible for personal belongings. WSMA is not responsible for any lost or stolen items.
7. Contestants in any Miss Divisions must have never been married legally or common law.
8. **Any contestants, judges, officials and volunteers** must not have any illegal act, felony, criminal, misdemeanor or record. If anyone falsifies or violates before, during or after the event he/she will be automatically disqualified, rejected and/or expelled from any WSMA events, but any applications, documents or fees will not be returned or refunded.
9. During the three(3) years period after receiving any titles awards from WSMA, if any one engaged in any illegal, unlawful, false, violation, dishonoring act(s), or unlawful acts, he/she will automatically lose any titles and/or privileges from WSMA or WSMA events, and is responsible for returning all awards, prizes, gifts and/or funds, and must notify WSMA with a certified letter.
10. **Any contestants, judges, officials and volunteers** must not be involved with any illegal fix, bribery, influence, prearrangement, dishonest, unfair or corrupted judgments for the event. If anyone is involved in above illegal actions or activities, he/she will be punished and responsible for paying WSMA all legal fees, council fees, damages and punitive damages and save harmless WSMA. Furthermore, they cannot claim any damages or compensation against WSMA or any WSMA official(s) or WSMA related personnel.
11. Any contestants, judges, volunteers and officials are responsible of not disclosing any personal, group, WSMA and/or WSMA's event(s) related information and properties without formal written permission from the authorized WSMA official.
12. Event schedules, divisions and/or locations are subject to change.
13. WSMA or event director will reserve the right to refuse any application.
14. Maximum 3 coaches or assistants per competitor to assure fair competition and must display official pass(es).
15. Contestants are responsible to schedule their own competition events. No exceptions.
16. All prepaid tickets, coach's passes, and pre-registration material will be available at the event's pre-registration.
17. Any winners are obligated to represent WSMA or WSMA's events for 2 years.
18. Weapon, Talent and Team demo divisions have their own title but will not be able to compete for the Final Martial Arts Title for fair judgments.
19. **Competition Scoring:**
 - Presentations and points:** for National and International competitions.
 - a. Martial arts performance and presentation:
 - b. Formal evening dress presentation:
 - c. Written presentation:
 - 1) Delay or Overtime points deduction:**
 - a. 3 point deduction for every 10 seconds of **Delaying** (starting) or going **Overtime** (finishing) with the presentation.
 - b. All Martial Arts performance: max. 2 minutes time limit. After 2 minutes 10 seconds, judges will be stopped with a 5 point deduction.
 - c. Team Demo: max. 5 minutes time limit. After 5 minutes 10 seconds, judges will be stopped with a 5 point deduction.
 - d. Formal dress presentation: Presentation directions will be provided at event.

Following information is for the competition at the event site.**

20. **Competition hours:**
 - a. Preliminary competition:
 - a) Competition hours will be notified by e-mail or phone.
 - b) No spectators or assistants are allowed on the stage during the competition.
 - c) Any cameras, visual or sound recordings are not permitted without written permission from WSMA. The event videos and photos may be purchased from WSMA.
 - b. Finalist for the main exhibition will be announced after all preliminary competitions at the hotel or competition site.
 - c. Final competition will be at the Auditorium on Sunday:
 - a) Final Contestants must attend rehearsals to qualify for final presentation.
 - b) Cameras, videos, visual or sound recordings are not allowed without written permission from WSMA. The event video may be purchased from WSMA.
 - c) No one will be allowed on the stage except for contestant(s) and WSMA officials.
 - d) Backstage assistants/coaches must have official badges or written permissions from WSMA.
21. Music: Contestant(s) are allowed music during the performance. Only a CD - ready to play at the beginning only. No other formats are accepted.
22. All performances except for the Team Demo will be solo. Judo, Yudo or any other special discipline approved by WSMA may be performed with only one partner. Any one assistant can be for only one contestant and must be in the same category (Age & Sex).
23. Contestants must be older than 21 to use edged weapon. No weapon practice is allowed except only in authorized areas under own black belt instructor's supervision- must obtain a WSMA written permission.
24. Qualifications of WSMA.
 - a. Local, regional, state, national, and international events.
25. Judges must attend judges' seminars to qualify.
 - a. WSMA will decide the judges including martial arts instructors, teachers from local school systems and community leaders.
 - b. Contestant, WSMA members, or nonmembers may send a recommendation for the judges. Any contestants, judges, officials and volunteers must not have any illegal act, felony, criminal, misdemeanor or record. If anyone falsifies or violates before, during or after the event he/she will be automatically disqualified, rejected and/or expelled from any WSMA events, but any applications, documents or fees will not be refunded.
